SPORIFY 23.1.1

SPORIFY 23.1.1 was released early in July. It was a minor release responding to changes that EMA was making to its SPOR OMS API. EMA now employs an API request rate limiting mechanism that allows a maximum of 60 requests per minute per user and 1000 requests per minute for all users. As this applies to SPOR OMS ORG and LOC API endpoints that are used during the daily SPORIFY sync, we enhanced our OMS sync to ensure that it works with these SPOR API changes. We also took the opportunity to include some security patches and bug fixes in this release.
